

LICENSE AGREEMENT  
**For Use of “Awareness & Self-Confidence Poetry Book”  
(A Bullies Be Gone Project Byproduct)**



Between Sweet Harmony Productions / Bullies Be Gone Project (Licensor) and [Name of School/Organization] (Licensee)

### **1. Purpose and Grant of License**

This License Agreement (“Agreement”) is entered into between Al Johnson / Bullies Be Gone Project (“Licensor”) and the organization listed below (“Licensee”). The Licensor grants the Licensee a limited, non-exclusive, non-transferable license to access and use the Awareness & Self-Confidence Poetry Book (“the Work”) through an online digital link or portal for educational and enrichment purposes only.

### **2. Access and Use**

- Access is provided solely for enrolled students, teachers, and staff of the Licensee.
- Licensee will receive a unique, password-protected access link that may not be shared or posted publicly.
- Duplication, downloading, printing, redistributing, or uploading the Work to any other platform or website is strictly prohibited without prior written permission from the

Licensor.

- The Work may not be altered, excerpted, or combined with other works without written consent.

### **3. License Term and Renewal**

The standard license term is One (1) Year from the effective date below. The license is renewable annually upon payment of the renewal fee and mutual agreement. The Licensor reserves the right to update or revoke access if terms are violated.

Licensee agrees not to:

- Share the digital access link with unauthorized individuals or outside entities.
- Copy, reproduce, or distribute the Work in any form beyond the agreed number of students.
- Translate, adapt, or use the Work for profit-making or resale purposes.
- Upload or stream the Work publicly on websites, social media, or shared drives.

Violation of these terms may result in immediate termination of this Agreement and legal remedies.

### **6. Ownership and Copyright**

The Work and all associated materials remain the exclusive intellectual property of Al Johnson and the Bullies Be Gone Project. All rights not expressly granted under this Agreement are reserved by the Licensor.

### **7. Termination**

Licensor may terminate this Agreement upon written notice if Licensee breaches any term herein. Upon termination, Licensee's access shall immediately cease, and all copies or digital materials must be deleted.

## 8. Limitation of Liability

Licensor shall not be liable for any indirect, incidental, or consequential damages arising from use of the Work.

## 9. Governing Law

This Agreement shall be governed by and construed under the laws of the State of California, without regard to its conflict of law provisions.

## 10. Entire Agreement

This Agreement constitutes the full understanding between the parties and supersedes all prior communications, whether oral or written.
